London-Based Health Care Credit Union to Join WFCU Credit Union

WINDSOR, ON (March 22, 2023) – Following a unanimous member vote during Health Care Credit Union's ("HCCU") Annual General Meeting, held on Monday, March 20, the London-based credit union announced it will be joining Windsor-based WFCU Credit Union ("WFCU"). The proposed will see all HCCU staff retain their jobs and become employees of WFCU. Once the asset purchase is complete in June 2023, HCCU will operate under Healthcare – A Division of WFCU Credit Union. This union will benefit existing and prospective members and employees across both organizations and serve to further strengthen the financial and cooperative position of WFCU Credit Union across Southwestern Ontario.

"On behalf of WFCU's Board of Directors, Executive Team, management, and staff, I would like to express our thanks and gratitude to the HCCU membership and leadership team for putting your trust in our partnership. Our shared purpose means we can scale our healthcare offering faster, providing added products, service, and convenience to healthcare professionals, workers, and support staff across Ontario," said WFCU Credit Union President & CEO, Eddie Francis.

"We are very pleased to continue to expand our footprint across Southwestern Ontario with the acquisition of Health Care Credit Union," said WFCU Board of Directors Chair, Marty Gillis. "Both credit unions are rooted in a rich history of service to their members and believe in giving back to the communities we serve. As we embark on a growth strategy for Healthcare — A Division of WFCU Credit Union, we will ensure HCCU's remarkable history of serving the needs of its healthcare members and community is preserved and celebrated."

WFCU will create a new, dedicated division for healthcare professionals, workers, and support staff. It will bolster the current HCCU membership offering by providing access to multiple banking options for increased convenience, ongoing investment in the digital banking experience and product innovation, improved access to specialized financial expertise, and dedicated fraud and IT security resources. To support the growth of its service to healthcare members, WFCU will explore new additional branch locations and expanded delivery channels for members in London, enabling strengthened community support and local partnership opportunities.

"Aligning our operations with WFCU allows us to provide better opportunities for our members with immediate access to a greater variety of product and service offerings," said Jolanta Swiatek, President and CEO, HCCU. "In addition, our employees are being offered roles consistent with those they have today, as well as improved access to career growth and training. Both WFCU and HCCU possess strong community values and a desire to grow and expand in their service to the healthcare community, providing exemplary support and service for our present membership and those who will join us in the future."

Expected to be finalized in June 2023, once the asset purchase is complete, WFCU Credit Union will support a combined member network of 13 retail locations across Southwestern Ontario, including nine in Windsor-Essex, three in the Kitchener/Waterloo Region, and one in London, with a 14th retail branch in Chatham expected to open later this year. The Credit Union also operates a digital entity under Omnia Direct, strengthening WFCU's position as the 6th largest credit union in Ontario.
